We commemorate the 75th and 10th anniversaries of two major mass evictions of Pittsburgh residents done in the name of “urban renewal” and post-industrial “renaissance.” Federal housing policies have produced sequential displacements of urban residents, and Pittsburgh’s Black population has been particularly affected. Nearly 2,000 families were displaced from the Lower Hill in the mid-1950s, joined by hundreds more with East Liberty’s redevelopment in the 1960s. Another 200 families were displaced when the Penn Plaza apartment complex was demolished a decade ago. Keynote speaker, Professor Edward Goetz, will discuss the long history of racialized displacement in U.S. housing policy and how things can be different. Friday’s panels will include residents of these displacements, community organizers, faculty, student researchers, and policy makers who will explore impacts of displacement on Pittsburgh residents and advocate for strategies for ending displacement and reducing housing insecurity in our region.
